

DIRECTOR'S PROVISION No. 6/2017

Prices for guest accommodation in the Dormitories and Refectories of Charles University, for guests with special status, effective as of September 14, 2017

In accordance with the Code for Providing Accommodation Services and Meals at Charles University, part III, section 11, par. 3 (hereinafter "Service Code"), I hereby set this price list for guest accommodation for guests with special status. The prices set by this provision are considered favored market prices agreed by mutual agreement, as defined by § 2 of Act No. 526/1990 Sb., on prices, as amended.

The price list is binding for all accommodation facilities of Dormitories and Refectories, **and is effective as of September 14, 2017, for infinite period.**

For the purposes of this provision, the guests with special status, accommodated in Charles University dormitories, are the following:

- a) Non-studying partner, lodged together with a student and a child, upon presenting the marriage certificate or the affidavit of cohabitation;
- b) Graduate of Charles University or other university/college, within five years since the successful completion of study, upon presenting the certificate of completion, unless lodged in family dormitory;
- c) Graduate of Charles University lodged in family dormitory, within two years since the successful completion of study, upon presenting the certificate of completion;
- d) Non-studying partner, lodged together with a graduate and a child, upon presenting the marriage certificate or the affidavit of cohabitation;
- e) Participant of the lifelong learning program of Charles University, based on the written order of Charles University or upon presenting the certificate of participation in the lifelong learning program;
- f) Student of a private university/college in the regular or combined form of study in the Czech language, upon presenting the certificate of study, and participant admitted to study the regular or combined form in the Czech language, upon presenting the certificate of admission;
- g) Student of Erasmus/Sokrates programs at private universities/colleges, upon the written order of the European Office of the school;
- h) Student of high/secondary school and higher vocational school; a high school student can only be accommodated in a Charles University dormitory if he/she has already completed 18 years of age, and upon presenting the valid certificate of study.

1. Accommodation prices for guests with special status, under the points a), c) and d) – non-studying partners and graduates lodged in the family dormitory Hvězda

The family dormitory Hvězda can offer accommodation to a non-studying partner living together with a student and a child. The family dormitory can also accommodate a Charles University graduate within two years since the successful completion of study, upon presenting the certificate of completion, together with his/her non-studying partner and a child.

The aforementioned prices in the family dormitory refer to one bed per day, including current VAT and services provided.

- a) If the client and his/her child
only use a half of the unit, the total price is the standard price of two beds in an en-suite double/twin room.
- b) If the client and his/her child
only use a half of the unit, the total price is the standard price of one bed in an en-suite double/twin room, plus a price of child accommodation (Czk 26 per bed/day, VAT included).

The aforementioned prices in the family dormitory refer to one bed per day, including current VAT and services provided.

The accommodation price doesn't include the following services: electric power and water.

The client undertakes to pay these services by advance payments. The amount will be included in the Calculation Sheet, attached to the Accommodation Agreement for the family dormitory. The

advance payments for electric power and water will be cleared on the last day of each calendar year based on the actual consumption measurement and valid price lists. Other services are included in the accommodation price.

If the client and his/her child use the whole quadruple room, the total price is four times the aforementioned bed price.

This provision cancels the Director's Provision No. 16/2015 – Price list for guest accommodation in the Dormitories and Refectories of Charles University, for guests with special status, effective as of September 1, 2015, issued on May 29, 2015, and Attachment 1, effective as of March 1, 2016.

This provision is valid on the date of issue, and effective as of September 14, 2017.
